## **New Webcast: Proposed Registration Changes (Please note this webcast is now available in French)**

IIROC published for comment the next iteration of the Plain Language Rule Book on March 9, 2017.<sup>1</sup> We also published for comment proposed forms and guidance on investments in a Dealer Member.<sup>2</sup> The publications contain proposed registration changes. The objectives of these changes include:

- harmonizing IIROC requirements with applicable securities legislation found in National Instrument 31-103 *Registration Requirements, Exemptions and Ongoing Registrant Obligations* and its Companion Policy
- addressing gaps and implementation issues identified in existing Dealer Member Rules following the implementation of Registration Reform rule changes in 2009

- updating the Investor Application Form and the Investor Notification Form to reflect current practices and increase efficiency in the application process
- Addressing preliminary changes to IIROC's Continuing Education Program while our broader regulatory review is ongoing
