IIROC to Hold Settlement Hearing For BBS Securities Inc.

July 18, 2018 (Toronto, Ontario) – A hearing has been scheduled before a Hearing Panel of the Investment Industry Regulatory Organization of Canada (IIROC) to consider whether the panel should accept a Settlement Agreement entered into between IIROC staff and BBS Securities Inc. (BBS Securities).

The agreement concerns conduct involving BBS Securities directing its Order-Execution Only division to solicit clients and potential clients to recommend share purchases.

The hearing is not open to the public, but will become open in the event that the Panel accepts the agreement. If the agreement is accepted, the Panel's decision and the Settlement Agreement will be made available at www.iiroc.ca.
