IIROC to Hold Settlement Hearing For TD Waterhouse Canada Inc.

October 29, 2018 (Toronto, Ontario) – A hearing has been scheduled before a Hearing Panel of the Investment Industry Regulatory Organization of Canada (IIROC) to consider whether the panel should accept a Settlement Agreement entered into between IIROC staff and TD Waterhouse Canada Inc.

The agreement concerns allegations that TD Waterhouse Canada Inc. failed to adequately supervise the trading of a Registered Representative.

The hearing is not open to the public, but will become open in the event that the Panel accepts the agreement. If the agreement is accepted, the Panel's decision and the Settlement Agreement will be made available at www.iiroc.ca.

IIROC formally initiated the investigation into TD Waterhouse Canada Inc.'s conduct in November 2017. TD Waterhouse Canada Inc. is an IIROC-regulated firm.
