IIROC to Hold Settlement Hearing for Former Hamilton Investment Advisor Donald Willson Bridgman

April 13, 2018 (Toronto, Ontario) – A hearing has been scheduled before a Hearing Panel of the Investment Industry Regulatory Organization of Canada (IIROC) to consider whether the panel should accept a Settlement Agreement entered into between IIROC staff and Donald Willson Bridgman.

The agreement concerns allegations that Mr. Bridgman borrowed money from several clients and made untrue and misleading statements to representatives of his firm.

The hearing is not open to the public, but will become open in the event that the panel accepts the agreement. If the agreement is accepted, the Panel's decision and the Settlement Agreement will be made available at www.iiroc.ca.

IIROC formally initiated the investigation into Mr. Bridgman's conduct in February 2017. The conduct occurred while he was a Registered Representative with the Hamilton, ON branch of Assante Capital Management Ltd., an IIROC-regulated firm. Mr. Bridgman is no longer a registrant with an IIROC-regulated firm.
