## **IIROC to Hold Settlement Hearing For Former Halifax Investment Advisor Barry Mosher**

**March 22, 2019 (Toronto, Ontario)** – The Investment Industry Regulatory Organization of Canada (IIROC) has scheduled a hearing to consider whether a Settlement Agreement between IIROC staff and Barry Mosher should be accepted.

The Agreement concerns allegations that Mr. Mosher made unsuitable recommendations and failed to remain informed of essential facts about a client.

The hearing is not open to the public, but will become open in the event that the panel accepts the agreement. If the agreement is accepted, the Panel's decision and the Settlement Agreement will be made available at [www.iiroc.ca](http://www.iiroc.ca).

IIROC formally initiated the investigation into Mr. Mosher's conduct in February 2017. The conduct occurred while he was a Registered Representative with the Halifax branch of Canaccord Genuity Corp., an IIROC-regulated firm. Mr. Mosher is no longer a registrant with an IIROC-regulated firm.
