IIROC to Sanction Former Mississauga Investment Advisor William Alan Heakes

March 8, 2019 (Toronto, Ontario) – The Investment Industry Regulatory Organization of Canada (IIROC) has scheduled a hearing to consider whether a Settlement Agreement entered into between IIROC staff and William Alan Heakes should be accepted.

The Agreement concerns allegations that Mr. Heakes made unsuitable recommendations for three clients.

The hearing is not open to the public, but will become open in the event that the panel accepts the agreement. If the agreement is accepted, the Panel's decision and the Settlement Agreement will be made available at www.iiroc.ca.

IIROC formally initiated the investigation into Mr. Heakes's conduct in January 2016. The conduct occurred while he was a Registered Representative with the Mississauga branch of Mackie Research Capital Corporation, an IIROC-regulated firm. He is no longer a registrant with an IIROC-regulated firm.

IIROC investigates possible misconduct by its member firms and/or individual registrants. It can bring disciplinary proceedings which may result in penalties including fines, suspensions, permanent bars, expulsion from membership, or termination of rights and privileges for individuals and firms.
