IIROC to Hold Settlement Hearing for Toronto Investment Advisor Shane Dubin

May 2, 2019 (Toronto, Ontario) – The Investment Industry Regulatory Organization of Canada (IIROC) has scheduled a hearing to consider whether a Settlement Agreement entered into between IIROC staff and Shane Dubin should be accepted.

The Agreement concerns allegations that Mr. Dubin recommended and facilitated futures and options trading, for which he was not approved, outside of his Dealer Member firm.

The hearing is not open to the public, but will become open in the event that the panel accepts the agreement. If the agreement is accepted, the Panel's decision and the Settlement Agreement will be made available at www.iiroc.ca.

Hearing Date: May 29, 2019 at 10:00 a.m.

IIROC formally initiated the investigation into Mr. Dubin's conduct in April 2018. The conduct occurred while he was a Registered Representative with the Toronto branch of Scotia Capital Inc., an IIROC-regulated firm. Mr. Dubin is currently registered at Canaccord Genuity Corp., an IIROC-regulated firm.
