DECISION ON THE MOTION

Motion

- ¶ 1 The Motion was for an Order (the "Order") expelling MF Global Canada Co. ("MF Global") from IIROC and terminating its rights and privileges of membership.
- ¶ 2 The hearing proceeded in writing pursuant to IIROC Rules 8212, 8409, 8413 and 8426. The Hearing Panel considered the materials filed in support of the Motion.

BACKGROUND

- ¶ 3 Pursuant to an order by an IIROC Hearing Panel on November 1, 2011, MF Global's membership in IIROC was suspended.
- ¶ 4 MF Global was declared bankrupt pursuant to an order of the Ontario Superior Court of Justice (the "Court") issued on November 4, 2011.
- ¶ 5 The wind-up of MF Global is complete.
- ¶ 6 After completing its duties, the trustee in bankruptcy of the estate of MF Global was discharged as trustee by order of the Court.
- ¶ 7 To date, MF Global has complied to the satisfaction of IIROC Staff with the terms of the order of the Court discharging the trustee.
- ¶ 8 MF Global does not hold client assets.
- ¶ 9 Since November 1, 2011, IIROC has not been advised of any client complaints against MF Global.

- ¶ 10 IIROC Staff is satisfied that there have been no new developments that would make the termination of MF Global's membership contrary to the interests of MF Global's former clients and does not believe that any new client claims will be received.
- ¶ 11 MF Global consented to the Order sought.

CONCLUSION

¶ 12 The Hearing Panel was satisfied that it was appropriate to grant the Motion and, accordingly signed the Order as requested.
